**National Charity League, Inc. Announces \$86 Million Fiscal Impact in FY 2022**

*-Nearly 3 million volunteer hours served to 6,000 philanthropy partners-*

**COSTA MESA, CA (Oct. 24, 2022)** – [National Charity League, Inc.](#) (NCL), the nation's premier mother-daughter non-profit organization, has announced nearly **3 million volunteer hours** were served in Fiscal Year 2022 (June 2021-May 2022) to over 6,000 philanthropy partners throughout the U.S., resulting in a \$86 million national fiscal impact.

NCL directly inspires philanthropy, culture and leadership while also enhancing and enriching the bond between mothers and daughters. Through the donation of members' time and creativity, NCL has made a significant national impact helping local communities thrive for nearly 100 years.

“In the past 10 years, we've doubled the number of states we're in, formed 42 percent more chapters, and our membership has grown by 75 percent,” said Nancy Dean, CEO of National Charity League, Inc. “We now have 295 chapters in 32 states and are continuing to strategically grow so that we can provide the NCL experience to more mother and daughters and serve more communities. Our exponential growth is proof there is a greater need than ever for the empowering programs and services we provide to our members and communities.”

NCL Chapters engage with over 6,000 philanthropies every year. The top national philanthropies served were American Heart Association, Operation Gratitude and the Alzheimer's Association. NCL recently reconnected with a

fourth national partner, the American Red Cross, which was the organization's first partner in 1925. Local philanthropy partners include Meal on Wheels America, Ronald McDonald House, the Humane Society of the United States, and Feeding America.

Philanthropic categories are wide-ranging, covering just about every type of cause. The top causes served by NCL Members include Animals; Children and Youth; Differently Abled; Disaster Response/Environment; Education; Family Services; Food; Health, Housing; Military; Older Adults; and Social Services.
